

## 2025 Park Partners Grant Proposal

## Community-Led Stewardship of Louisiana's Local Parks for Long-Term Sustainability

**The Mission:** Establish a statewide grant program that promotes private stewardship of parks by private citizens and businesses to build a culture of park philanthropy across Louisiana to build long-term sustainability.



# **Why This Matters:**

Louisiana's local parks are underfunded and often underutilized. Studies and empirical evidence have shown the transformative power of local residents when they steward their parks.

### Community-led park revitalization:

o Improves park quality and safety

o Strengthens social connections

o Spurs economic development

o Builds trust between residents and local government

### The Request

**\$800,000** to establish the Park Partners Grant Program.

**Grants of up to \$100,000 per project** are awarded to municipalities and park departments.

**12% of funds** are retained by LRPA to administer and oversee the program.



## 5-Year Program Plan

**Year 1:** \$800,000 for a minimum of 7 grants to parks departments with the assistance of private residents and businesses, and coaching by LRPA.

**Year 2**:\$500,000 to promote successes from year 1 and to award up to 4 more grants, using Lessons learned from year 1 for the most successful models for private stewardship.

**Year 3:** \$500,000 to promote successes from years 1 & 2 and to award up to 4 more grants, using lessons learned from years 1 & 2 for the most successful models for private stewardship.

**Year 4:** \$500,000 to promote successes from years 1 - 3 and to award up to 4 more grants, using lessons learned from years 1-3 for the most successful models for private stewardship.

**Year 5:** \$200,000 to promote program successes and to assist local communities and parks departments with establishing private support structures for long-term sustainability.

## **Grant Requirements**

Community Stewardship Requirements

Minimum 10% match (cash or in-kind), with
preference for private contributions (businesses,
civic groups, donors).

# Park Partnership Team (3+ residents) required:

Complete LRPA's stewardship orientation + 2
technical guidance meetings
 Lead public input for design/programming choices
 Host volunteer events/programs to implement &
launch the project

# Eligible Uses (examples):

- Play, fitness, and shade amenities
- Trails and wayfinding signage
- Native landscaping and green infrastructure
- Lighting and safety features
- ADA access improvements
- Public art and community gathering spaces
- Start-up programming, community gardens, volunteer tools/supplies

### **Accountability & Oversight**

**Statewide RFP** within 90 days of appropriation

### All awards under a grant agreement require:

o Quarterly progress reports (budget, milestones, match, volunteer hours) o Final report with outcomes, photos, and 12-month stewardship plan

(Awards determined by LRPA selection committee)
All funds tracked and reported per state requirements



### Louisiana Case Study: Palmetto Island State Park

In 2010, volunteers formed **Friends of Palmetto Island State Park** when budget cuts threatened its closure.

## From 2023-2024 alone, the group

o Raised **\$100,000+** in cash and in-kind donations o Volunteered **11,970+ hours** 

o Hosted 16 free community events

o Restored the native **Abbeville Red Iris** flower population
